Application for Discharge from Accountability
Government Code Section 25259.7

The Court Enhanced Collections Program (Collections) of the Superior Court of California, County of Mariposa (Court) respectfully applies to the Presiding Judge of the Court for a discharge from accountability for the court-ordered debt or bail listed in Attachment A, that it would otherwise be responsible for collecting. The request is based on one or more of the following: 1) the amount is too small to justify the cost of collection; 2) the likelihood of collection does not warrant the expense involved; 3) at least 5 years for infractions or 10 years for misdemeanors have elapsed from the date the debt became delinquent; 4) all required collection efforts have been performed, including Penal Code Section 1463.007.

Specifically, Attachment A contains a list of <u>80</u> infraction cases with a balance due of <u>\$69,886.00</u> and <u>81</u> misdemeanor cases with a balance due of <u>\$77,722.63</u> extracted from the Court's case management system, JALAN. All the cases listed have been referred to Collections, GC Services and/or to the Franchise Tax Board, Court Ordered Debt program and been returned from FTB-COD. Collections have been unsuccessful as the date of the last payment or the date the case was filed if no payment received, is at least 5 years old for infraction cases, and 10 years old for misdemeanor cases. Due to these factors, the Court Collections Program has determined that all reasonable collection efforts have been taken and the likelihood of collection does not warrant the expense involved.

A discharge from accountability does not constitute a release of any person from liability for payment of amount owed.

Total amount requested to be discharged from accountability: \$147,608.63

The names of the persons liable and the amount owed by each are incorporated in the attached report.
